No.LESI-LL1-IIM1-0016-2018- **8110**/LESI., In exercise of powers conferred by the following Acts and in supersession of all previous notifications issued in this regard, the State Government do hereby appoint the **District Labour Officer** to exercise powers under the following Acts, within the defined jurisdiction as mentioned in Notification No.8096/LESI, dated 03.12.2018 with effect from the date of issue of this notification, as

A. Inspector
