No.LESI-LL1-IIM1-0016-2018- **8115**/LESI., In exercise of powers conferred by the following Acts and in supersession of all previous notifications issued in this regard, the State Government do hereby appoint the **Assistant Labour Officer** to exercise powers under the following Acts with effect from the date of issue of this notification, as

A. Inspector

2. Under Sub-section (3) of Section 14 of the Payment of Wages Act, 1936.
3. Under Sub-section (1) of Section 9 of the Equal Remuneration Act, 1976.
4. Under Sub-section (1) of Section 27 of the Payment of Bonus Act, 1965.
5. Under Section 17 of the Child and Adolescent Labour (Prohibition and Regulation) Act, 1986.
6. Under Sub-section (1) of Section 28 of the Contract Labour (Regulation & Abolition) Act, 1970.
7. Under Sub-section (1) of Section 20 of the Inter-State Migrant Workmen (Regulation of Employment & Conditions of Service) Act, 1979.
8. Under Sub-section (3) of Section 42 of the Building & Other Construction Workers (Regulation of Employment & Conditions of Service) Act, 1996.
9. Under Sub-section (1) of Section 6 of the Beedi & Cigar Workers (Conditions of Employment) Act, 1966.

C. Registration of workers

1. For registering building workers as beneficiaries under Sub-section (4) of Section 12 of the Building & Other Construction Workers (Regulation of Employment & Conditions of Service), 1996
2. For registering unorganized workers as beneficiaries under Unorganized Workers Social Security Act.

D. Cess Collection

Cess Collector under Section 7 of the Building & Other Construction Workers Welfare Cess Act, 1996 [Clause (f) of Rule-2 of Building & Other Construction Workers Welfare Cess Rules, 1998].
